

The Village Action Plan 2016

Introduction

In 2012, the residents of Quendon and Rickling were asked to complete a Community Questionnaire. From the information and statistics gathered in response to this, a group of volunteers published The Quendon & Rickling Village Plan in the summer of 2015. This document not only provides a snapshot of life in the community, but also highlights recommendations for further actions that should be taken to address the issues raised by residents.

This Action Plan is the next step in achieving the initial objectives of this process: taking stock of local infrastructure and services, identifying the needs of the community and preserving what is good in our villages. This is a working document and will be under constant review. It not only prioritises the proposed actions, but also identifies which agencies may be involved in working towards the suggested targets. It may not be possible to act upon every recommendation in the short term, but each will be fully investigated and closely monitored.

The current Action Group will oversee this process, but more volunteers will be needed to form small working groups who will work together on various areas of The Plan over the coming months. If you would like to volunteer, then please contact a member of the Action Group listed below:
