- After a recent Ofsted inspection, Essex schools have been assessed as "Outstanding".
- A number of children in Essex (1924) are being home-schooled. Some parents are not satisfied that schools are offering sufficient educational standards. There is also a feeling amongst some parents that children with special needs are not being catered for adequately. Essex County Council is unable to intervene.
