1252. County and District Councillor reports

District Councillor Neil Hargreaves (report submitted in his absence)

Three motions were passed at the last UDC full Council before the election:

- 1. Objecting to the Walden Amenity Site booking system as not needed the chief exec has written on behalf of the council to Essex asking for a rethink
- 2. To government concerning Essex 'devolution' and requirement to have an elected mayor as an extra tier of government in order to obtain levelling up funds. The funds potentially on offer sound large but over 30years and spread across the county on an annual basis would not even cover the 23/24 budget unspecified cuts made just by one council (ECC) never mind what is being cut by the other 15 or so councils in Essex. So the chief exec has written to Michael Gove who heads the Department for Levelling Up, Housing and Communities asking that council finances be put on a sound long term basis so we can plan properly
- **3.** Another motion and letter to Michael Gove on Right to Buy which has cut UDCs social houses from 6000 to just under 3000, and we still lose 12 a year, but the requirement to house people has grown not diminished. The request is either give councils 100% of the proceeds from sales, which are currently significantly discounted to the buyer and then councils don't get to keep all the remaining cash either, and spending it is hedged with rules, or abolish Right to Buy as already done in Scotland and Wales

On the Neighbourhood Plan, you have the minutes and 'scene setting' note from the consultants from the first meeting. Would be good to have that on the PC website. A second meeting has been held, just Steering Group members. UDC have been written to confirming that we will be doing new site allocations, and asking them to confirm that we will therefore need an Environmental Assessment (which they arrange), asking for NQRNhP2 to be noted on the UDC website, and asking to confirm that grant cash is available from them.
