Paul Wilsher (PW) had advised that checking for the presence of great crested newts in the ponds was required. A quotation of £438 for this testing has been received. The PC would like this to proceed, and the clerk will advise PW.

1409. County and District Councillor reports

Planning

The latest housing build figures (which councils have no influence over) have shown a slowdown of building. This triggers a 20% buffer on top of the 5 year land supply which we had at April 2023 and so UDC no longer has the required 5 years and the balance towards giving permission has reappeared.

Good news is the Dec 2023 reissue of the NPPF gives Neighbourhood Plans a 5 year life at full strength, so we have a full weight NHP, which has been very effective at opposing unsuitable applications.

There is a Local Plan intervention letter from Mr Gove demanding a revised Local Development Scheme.

Neighbourhood Plan

With Q&R not wanting to go for any sites we are concentrating on Newport. A draft Housing Mix analysis has been done by AECOM, now with us for fact checking. Also a Strategic Environmental assessment has just started which looks at sewerage, water, general ability to sustain development.

Budget

Our 24/25 budget is in preparation. We are not in the position of other authorities, typically those with social care responsibility, who are going to s114 effective bankruptcy, but it will still be a tough budget. More below inflation govt funding and a bar on council tax increase above 3% means a hard look at non statutory spend. The council gives £700k a year, nearly 5% of the budget to voluntary bodies and grants such as to Citizens Advice.

Ray Gooding (RG)

RG has spoken to Kemi Badendoch regarding the ongoing problem of the B1383 footpath. GS asked if work was likely to proceed this year. RG confirmed that it would. He has been trying to get an agreement for the work to be carried out in stages. Initially the bushes and shrubs would be cleared with the re-surfacing work to follow. This clearing work would need to be carried out before bird-nesting season. GS pointed out that the nesting season starts around late February early March.

The budget was currently being considered and is likely to result in increased council tax.
