## From the Vicarage Study Rev. Neil McLeod, Priest-in-Charge of Newport with Widdington, Quendon and Rickling.

In the Church of England when a priest reaches the 10th anniversary of their ordination as a Deacon they are entitled to take a 3-month period away from regular duties. This period is called an Extended Study Leave, and it comprises three different parts:

- The first part is that it should contain a spiritual retreat. Ministry can be quite draining so it is vital that priests take time out to focus on their own relationship with God.
- The second part is a period of study, something that may not be possible alongside the day-to-day duties of being a parish priest.
- The third part is to rest and relax. If a spiritual retreat is to recharge spiritual batteries, so a period of rest is needed to recharge physical batteries.

As I now qualify having celebrated my 10 years in June 2018, I am taking a 3-month Extended Study Leave between September and November this year. So far, the plans for my study leave include:

- A retreat in early September focusing upon how the light of life, of God's creation can be seen through the means of photography. I'm not an expert but enjoy taking photos. The retreat also incorporates periods of silence which I'm not used to, so it will challenge me spiritually.
- I'm also likely to spend some time at Trinity College in Bristol which is where I studied before ordination.
- As part of my rest I have booked a break in Venice. I am looking forward to exploring the different sights there are to see.
- My study comes under the title of 'Christian Identity with specific regard to the Transgender Community'. I prefer to study something that is real life as opposed to uses of buildings or saints, etc. I also prefer to listen to people's individual life stories although I have at least two theological books on the subject that I am going to read. I also hope to visit people across the UK to hear their stories. My hope is that the study informs me and us of our Christian identity no matter who we are.

Sometimes I shall be here, and other times I shall be away so you may not see me during the three months. When I am at the vicarage I shall worship elsewhere in other churches. The churches in Quendon & Rickling will continue without me with our normal pattern of worship on a Sunday morning. Our communion services will be covered by Revd. Chris Bishop who has graciously offered to cover the service in the parish. Other services such as Harvest Festival will be covered by others in the church. The Archdeacon will be taking our Remembrance Sunday service in Newport. One change is that out annual Commemoration Service will be moved to January, as it makes sense for me to be there as I'll have conducted the bulk of the funeral services from which families are invited.

I shall return to duties on Sunday 1st December all ready for the build up through the Advent season to our Christmas services. Hopefully I'll be well rested, and recharged physically and spiritually and looking forward to being back with you all once again.

#### **Quendon & Rickling Speedwatch**

Since starting our speedwatch team in January of this year we have recorded and submitted around 500 offenders to Essex police, in addition details of drivers speeding without insurance or MOT'd vehicles have also been reported.

#### The Cricketers Arms opening end of the month

To nicely coincide with the Quickling Festival on 10th August. This promises to be a great day with lots of events and prizes and other stuff, including beer. Not to be missed!

#### **Community Special Constables**

It appears that this is going to be on hold for the time being. According to the coordinator Les Hawkins, and I quote, "Due to the success of the scheme and the number of the posts that are currently vacant, Essex Police will now be proactively supporting recruitment initiatives for these vacancies together with the Parish/Town Councils.

As a result of this, Essex Police are placing a temporary pause to the scheme for any councils not already registered."

#### <u>Broadband</u>

Mobile phone coverage continues to be a problem. The Parish Council has again written to our MP Kemi Badenoch to see if she can put a boot up the appropriate area of government. Gigaclear is holding a meeting on the 23rd July (at Stansted Airport).

#### **Other news from the Parish Council meeting**

The 40 mph limit in the buffer zone between the 30 and 50 limits has been approved and will be introduced shortly.

The skip will be in the village soon.

#### The Foxley 2 development

The contractors have suggested a meeting with the Parish Council but, on the advice from our District Councillor, the Council has declined.

#### From the Chairman of the Parish Council

Dear Fellow Villagers!!

The summer is now in full swing and hopefully by the time you are reading this, The Cricketers Arms will be open again and you will have sampled your first pint of beer or glass of wine already and welcomed the new publicans, Harry and Sam to the village. I can honestly say that the pub has been missed very much over the past few months, not only to have a drink in but to catch up with fellow villagers. It is such a great meeting place, so do go along and support it!

You will have seen flyers and banners promoting Quickling Festival on Saturday, 10 August. This is the brainchild of one of our councillors, Carrie Williams, who is very keen to incorporate all the villagers in a community event. There is also an article in this issue describing exactly what you will be able to do before and on the day and I really do hope that you will be able to come along and sample some delicious waffles and local gin as well as many other delicacies. We realise that it is quite short notice this year but hopefully if it is a success, there will be many more Quickling Festivals in the coming years! This year the funds being raised will go towards the Community Football Field.

As you all know, the minutes of the monthly meetings are always available on the website for you to read and everyone is very welcome to attend. The more the merrier!! We have been very fortunate recently to have a number of members of the public attend.

One of the most relevant items raised this month (well, lets be honest, every month!!) is Gigaclear. Tom Duncan, who is our "broadband specialist" has written to Kemi Badenoch, our local MP, explaining our position and that Gigaclear needs much closer supervision as we have effectively been abandoned! He has also written a piece for this month's issue updating you all on where we stand at the moment. I think we are all at our wits end and I can assure you we are doing everything we can to speed the process up. We have also sent Kemi Badenoch a letter regarding mobile phone coverage in the villages, as we know that coverage is still very poor and makes payment services effectively impossible in some cases and requesting that she bring pressure on concerned parties to rectify this problem.

Planning permission has been submitted for Foxley 2 for 9 new houses. The village has the opportunity to meet the developer for this site so they can present their plans to us but we have been advised against this as developers are not really interested in what the locals say, it is just a box ticking opportunity and any questionnaire answers are not published in full! Saying this, as Foxley 2 cannot be stopped it might be an idea for the Parish Council to meet them to discuss potential benefits for the village.

#### From the Chairman of the Parish Council (cont.)

On Tuesday, 3 September, we will be flying the Red Ensign, the UK Merchant Navy's official flag, on the green to show our support on Merchant Navy Day. It honours the brave men and women who kept our "island nation" afloat during both World Wars and celebrates our dependence on modern day merchant seafarers.

Finally, sorry to "dump" this on you, but I would like to ask everyone who take their canine friends for a walk either on the Green or on the footpaths in the surrounding woods and fields to PLEASE pick up your dog's poo! On one footpath alone, leading from Bradleys Barn, I counted 40 dog poos left to fester!!! Please carry a dog poo bag with you at all times and place them in the bins provided. I appreciate it may be some way away from where you are but please be considerate! Abandoned poos, in future, will be sprayed with a brightly coloured chalk based marking spray to make other walkers aware of the dangers ahead!! Thank you!

#### **Broadband update**

Hello all, a quick note to update everyone with the state of broadband in Quendon and Rickling. Sorry no good news to report at present.

#### (1) Gigaclear has put our project on hold.

Gigaclear are part way through delivering fibre-to-thepremises to our villages.

We are part of a commercial project that goes from Farnham in the south to Duddenhoe End in the north. As it's a commercial project there is no government subsidy available (ie **SuperfastEssex have no role**) and there is no effective oversight of the project.

Gigaclear have been working to bring another contractor on board to finish off the network but so far after five months they have not found the right partner (at the right price!).

Our MP wrote an open letter to the Gigaclear CEO last week requesting more details of when they will resume work which is a step in the right direction. I too have written to Mrs Badenoch emphasising the lack of supervision and the lack of any way to effectively put pressure on the company when they miss their deadlines. We shall see if anything comes of this.

Gigaclear are active elsewhere in Uttlesford implementing government-subsidised projects for SuperfastEssex most recently in Widdington. They have finished there for the time being and have done the same there as here ie laid the cable but not yet connected any properties up.

I believe that when they connect up Widdington they will soon afterwards connect up our cabinet on the Green. That still leaves several pieces of work to do namely:-

- finish laying fibre along Cambridge Road past the Church

- connect up the new builds

- connect up Brixton Lane

Maybe the first connections will be hooked up by the end of 2019? We shall see.

#### (2) Openreach.

There was a glimmer of hope that people on Rickling Green Road would be able to be connected up to the new cabinet 9 on the Green, but alas that has not come to pass. I have not heard a convincing reason why not yet.

Openreach still have no definite plans to upgrade Cabinet 10.

Recently there have been reports that some people have been refused connection to standard (snail-paced) broadband, which should not happen. A broadband journalist is investigating that situation in more depth.

#### (3) Other options.

Where they can, some people have switched across to a 4G package (ie mobile internet). For a fairly good price they can get unlimited broadband at a reasonable speed, but of course that depends whether you can get 4G. You might be able to get a better signal with an external aerial for 4G but if you're listed it's more complicated.

#### (4) Community Fibre.

Rickling Church End have successfully initiated a Community Fibre project with Openreach covering the houses around Rickling Church. They have used subsidy vouchers so the project won't cost residents anything which is great. Should be implemented by the end of 2019.

We did look into setting this up for Quendon as well but at the time Gigaclear were getting started so we dropped it. In fact it would take a year to deliver, and there's no guarantee we could use vouchers here because Gigaclear are active so a Community Fibre project subsidised by the government would be anti-competitive.

In summary - no tangible progress. Gigaclear remain the best bet and we are hoping for some action following our MP's intervention.

To add to your enchantment of the day, experience the overhead foliage moving in the wind and making a suthering sound! On your travels you may notice a socker, the rift in an oak caused by a lightning strike, or some frith growth of thorns or bramble spreading out from a neglected hedge.

The Quendon & Rickling Parish Council are delighted to announce the first annual QUICKLING FESTIVAL which will take place on Saturday 10 August 2019, on Rickling Green. This year we are raising funds for the upkeep of the Q&R Community Football Pitch.

The event is centred around a circular (Winstanley's) Dragon's Treasure Quest trail through our beautiful villages and countryside, marked on a map with clues and riddles to decipher, and 'treasures" to find along the way. The trail is open between 11am and 4pm. The trail will take approximately an hour.

There will be fun for all ages on the green too: we have horsebox-conversion food and drink options available (serving everything from crafted G&Ts, gournet waffles to "posh" toasted sandwiches) and the newly re-opened Cricketer's Arms will be putting on a BBQ. #### **Report from Affinity Water**

#### <u>May rainfall below average and water resources remain</u> <u>below average</u>

Our central region received 61% of the long-term average rainfall in May and groundwater sources remain below average.



As usual for this time of year, groundwater levels start a natural decline as most rainfall is used by trees and plants for growth or is lost to evaporation.

October to March is the critical recharge period when rainfall is expected to reach the aquifers (porous rock where groundwater is stored), which is used to supply 60% of Affinity Water customers. The dry and relatively warm weather in April and May has also decreased moisture in soil. When soil is dry, this decreases the amount of rainfall that is able to reach the aquifer as rainfall is absorbed by the soil.

We have welcomed the rain that has fallen so far in June, which has reduced the demand for water. We will be providing more information on total June rainfall in the July update.

Whatever the weather, we continue to ask customers to save water. This is good for your local environment and will help you save energy, and money!

Here are a few simple things you can do to save water:

- Take advantage of the recent downpours and install a water butt, which collects rainwater from your roof.
   Water stored now can be used during drier periods instead of relying on treated drinking water for your plants or even washing the car.
- When potting up your planters use a small amount of gel crystals. They absorb water and can help retain the moisture in the soil
- Fix dripping taps. You could save over 5,500 litres of water a year. If you need to find an approved plumber visit www.watersafe.org.uk.\*

#### Neighbourhood Plan

We are continuing to progress towards the Examination. UDC have confirmed that in their opinion the Plan does not need a 'Strategic Environmental Assessment and Habitats Regulations Assessment Screening'. However, this is subject to confirmation from Natural England, the Environment Agency and Historic England. UDC have given them their views and they have till 14th August to respond.

UDC have also suggested that the Consultation Statement needs further work. In particular to show how consultation responses may have resulted in alterations to the Plan. So this is being done. The Plan will go to another six-week consultation, so we need to show that everything has been considered and that there are no weaknesses for developers to raise further issues (in order to push their sites and block any policies which might disadvantage them).

The consultation responses will go direct to the Examiner. At the Local Plan examination, currently in progress, the meetings are public and there is interaction between speakers, councillors, council officers and the Inspectors. But a Neighbourhood Plan examination is only on paper and we don't get to meet the examiner. He or she may make alterations or even deletions and,

barring errors of fact, it is take it or leave it. They can however ask questions via UDC. It seems a somewhat odd process as there is no negotiation over anything deemed to need changing.

Here are extracts from the UDC report on the Neighbourhood Plan. Note they only comment on policies. There are also many recommendations. For these we can say what we like! The extract gives a useful independent summary of the statutory/policy parts of the Plan:

The Newport Quendon & Rickling NP would, if adopted ("made"), form part of the Statutory Development Plan and as such will contribute to the Framework for future development consent of projects. However, the plan will sit within the wider framework set by the National Planning policy Framework (NPPF), the strategic polices of the Uttlesford District Council Local Plan (2005) and the emerging Local Plan 2011 - 2033. The Draft Newport Quendon & Rickling NP includes the following policies:

Business & Local Economy

- NQRBL1 Support of new and existing businesses
- NQRBL2 Change of use on upper floors.
- NQRBL3 Business parking.

#### • NQRBL4 High speed internet connection.

These polices support new and existing businesses at existing business locations and within walking or cycling distances of homes of an appropriate scale to their location and where they will sustain and enhance the rural economy in the Plan area. Change of use to residential on upper floors will be supported where the ground floor uses remain in business use. More parking to support businesses will be encouraged provided there is no damage to the Conservation Areas.



#### <u>The red line is Conservation Area and the black is the</u> Local Plan and Neighbourhood Plan development limit.

#### <u>Air Quality</u>

- NQRGSE1 Air quality impact of development proposals
- NQRGSE2 Cumulative impact of developments on clean air and traffic congestion

These two policies require the consideration of impacts on air quality of new development. Developments of 10 or more dwellings will need to be accompanied by a Transport Assessment as well as an Air Quality Impact Assessment. Where adverse impacts are identified, mitigation measures will be required.

#### Water/Climate Change/Flooding

- NQRGSE1 Discharges into watercourses.
- NQRGSE2 Locally supplied evidence of flood risk.

Policy SE1 above requires that any development that will lead to discharges into watercourse only be permitted where it can be demonstrated that risk of flooding will not be increased or at least not made worse. Policy SE1 requires decision makers to take into account locally available information with regard to flood risk.

#### Footpaths

• NQRGSE3 Footpaths and access to the countryside. Policy NQRSE3 seeks new footpath links when development comes forwards

#### Health and Education

- NQREH1 General Practice
- NQREH2 Primary school places

*Policy NQREH1 General Practice supports the timely expansion of GP practice* 

Policy NQREH2 requires permissions for residential development to be conditional of availability of primary school places.

#### Direction of development

NQRHA1 – Coherence of the villages

This policy provides criteria for the location of new development in the plan area.

It supports, in principle, new development within the Newport development limits boundary (uses the same boundary as that emerging through the Local Plan):

Resists development beyond these boundaries in Newport further along the B1383 (both north and south)

Resists development outside the Cam Valley (defined in accompanying map)

Resists development outside the Quendon and Rickling development limits other than for development appropriate in the countryside.

NQRHA2 – Building on Brownfield Sites

Policy encourages development on existing brownfield sites.

• NQRHA3 – Connection with the countryside

Establishes two areas where new development will not be supported due to the value these areas have to providing the settlement with connection to the countryside

• NQRHA4 - Building in the countryside

Whilst the plan as a whole does not support development in the countryside, this is a policy providing criteria for those scenarios where development does come forward (for uses appropriate in the countryside presumably).

• NQRHA6 Foxley House, Quendon, site allocation. (Ref '2 Que 15')

This policy allocates land at Foxley House, Quendon for

the development of 19 dwellings. It is linked to an emerging site allocation in the emerging Local Plan and provides five site specific criteria including need to consider the Conservation Area, access arrangements and provision of footpath directly into the village. The site is directly adjacent to the conservation area and is surrounded by residential development to the north, west and south and by the B1383 to the east.

In the process of allocating Foxley House, the NP group have assessed all available sites and have prepared a site assessment report which is available to view alongside their plan on their website https://nqrplan.org/evidencedocuments. This site was assessed both by Uttlesford District Council and Newport, Quendon and Rickling Neighbourhood Plan group to be suitable, available and deliverable for development. The site is approximately 0.9ha

Housing, Planning and Design

- NQRHD1 Parking Standards
- NQRHD2 Housing Design
- NQRHD3 Use of Specimen Trees
- NQRHD4 House sizes
- NQRHD5 Affordable homes and local connection -
- NQRHD6 Affordable housing -

The above policies are non-site-specific but provide requirements with regard to off-street car parking provision, design, trees, mix of sizes of homes on a scheme and a policy seeking provision of affordable housing.

#### Roads and Moving Around

- NQRTR1 Extension of speed limits and footways
- NQRTR2 Mitigation of traffic impacts
- NQRTR3 Safe access to schools and village facilities

Policy NQRTR1 above requires funding towards implementing speed limits and installation of footways in the event that ribbon development is permitted along the B1383 (something not supported by the plan). Policy NQRTR2 requires contributions from developers towards the mitigation of traffic impacts such as promotion of sustainable transport measures. Policy NQRTR3 requires developers to provide safe routes to school where necessary to achieving better connectivity within the villages.

Sport, Community and Leisure

- NQRSCL1 Retention of existing community facilities
- NQRSCL2 Financial contributions from development
- NQRSCL3 Provision of amenity space and for ball sports
- NQRSCL4 Retention of sports fields

Policy NQRSCL1 above protects existing community facilities. Policy NQRSCL2 seeks contributions towards the provision of additional sport and leisure facilities in the parishes. Policy NQRSCL3 encourages developers to exceed the provision for amenity space and ball sports set out in the Local Plan. Policy NQRSCL4 protects existing sports fields.

The pre-submission Neighbourhood Plan and the full UDC screening assessment are both on https://www.nqrplan.org/evidence-documents.

#### **CRIME PREVENTION ADVICE**

#### **Catalytic Converter Theft**

Protect your vehicle from catalytic converter (CAT) thieves - they have been active here!

If yours is stolen, you will know because your vehicle's engine will sound different. Vehicles with high ground clearance, such as some 4X4s, are especially vulnerable, although the current trend also includes others.

- Park your vehicle in a locked and secure garage/ compound at all times.
- If this isn't possible park in a well-lit, area covered by CCTV where you can.
- Park so as to make access to the underneath of your vehicle and catalytic converter difficult; against a wall or parallel with another vehicle.
- Report suspicious activity by looking out for people 'working' under vehicles as they may not be the owners or lease holders, even if they have fluorescent jackets on.
- Consider installing a Thatcham approved alarm to your vehicle. Ones that activate if your vehicle is lifted or tilted are particularly effective.
- Mark your catalytic converter by etching your vehicle registration onto the metal shell, or by using a Secured By Design (SBD) approved forensic marking

solution which is heat-resistant. This makes it easier for police to trace the converter back to your vehicle and links offenders to a crime.

Consider fitting additional security on your vehicle(s) by installing an SBD or Thatcham approved CAT security product such as a clamp.

#### Summer Crime

During the summer months burglars take advantage of open gates, windows and doors.

An open or insecure garden gate will provide the thief with access to the back of your home. If you have unoccupied rooms that are accessible to others from outside or off flat roofs make sure the windows are closed. If you need ventilation in these rooms whilst at home at least lock the larger window and only have the small window open even during the daytime. If you only have bigger windows consider a lockable window restrictor and a small alarm sensor on the window to detect entry.

Leave any accessible door open or insecure and an opportunist thief will pop in and anything lying around

#### **CRIME PREVENTION ADVICE** (Cont.)

will be gone. It only takes a second for a thief to steal.

Tips for a crime free summer:

- 1. Don't leave property on display in the car. Don't assume that by pressing the button on the remote it is locked; try the handle too.
- 2. Don't attract a thief with visible insecure and unattended pedal cycles.
- 3. Keep side or rear gates, sheds and garages shut and securely locked.
- 4. Before going out or turning in for the night don't forget to check all doors; someone may have closed it, but did they lock it?
- 5. Check windows are closed. Make sure in case of fire that keys to windows and doors are readily accessible to occupants but not in view of possible burglars.
- 6. If you have an intruder alarm activate it when going out and activate the zone for the unoccupied area whilst in.
- 7. Don't take car keys to bed with you; where possible leave them in noisy drawer/location. Keep the keyless fob in a "Faraday" bag.
- 8. If you do hear a suspicious noise in the house that you are not happy, with dial 999 and make a noise, shout out; it could cause any intruder to flee. Remember

your life is more important than your property. If safe to do so, get a good description of the person/s and if possible the car index number and direction of travel.

- 9. Don't drop your guard when out. If you don't pay attention to your camera, mobile phone, sunglasses, purse or wallet and a thief sees them, they will steal them.
- 10. Be wary of announcing to the world on "social media" that you are away and your house is empty. Make sure your profile does not contain private information that would identify you or your address to a stranger.

Cancel regular deliveries when away and get a friend to keep an eye on your property; ensure neighbours have contact numbers for a key holder. Let someone park their car on your drive. Create the illusion that your house is occupied (TV simulator, lights and radio on timers, a doorbell that you can answer from your mobile phone); it is less likely to be broken into.

#### **Unwanted Communications**

(This is an extended version of information on our village web-site, www.quendonandrickling.co.uk)

The majority of email providers and financial institutions offer a way for you to report any scams that you receive. If you receive a suspicious email, forward it to the relevant company or organisation which can be found below.

Note that spammers and scammers are very wily and frequently use "spoofed" sending addresses. You have probably even received spam e-mails ostensibly from yourself! Your Editor uses SpamCop to deal with all spam e-mail. SpamCop uses the normally hidden header text in e-mails to identify the true origin of e-mails, as well as the true destination of any hyperlinks in the e-mails, to notify the relevant internet hosts of the wrongful activity of their subscribers. It does work, because sometimes when a complaint is made, the response is that the host has already indicated that the spamming complained of will stop.

Information is also included below on how you can reduce unwanted telephone calls and paper post. The Telephone Preference Scheme is said to be respected by reputable companies, but of course is ignored by the disreputable ones! The Mailing Preference Scheme is very good for reducing addressed spam post. The Post Office's opt-out scheme for unaddressed junk mail is less satisfactory, as it depends on the compliance of the Post Office staff. Neither of these schemes will stop delivery of leaflets by individuals, nor will they prevent delivery of *The Link*!
