Community Response Hub

The Community Response Hub is coming to the end of week 15 of supporting our vulnerable residents in the district. During the 'next steps' of the recovery phase we will continue to offer advice and support for all residents, but especially for those that have been shielding to help ease into the next stage whilst staying within government guidelines and remaining safe and well.

We will be helping to address any emerging issues, such as mental health and domestic abuse, by ensuring the appropriate referrals are made to the specialist services available and signposting our residents through the correct pathways.

The partnerships managed by the Community, Health and Wellbeing Team are now also holding their regular meetings virtually, allowing discussions around those emerging issues, and where they are able identifying funding to help address those problems.

The Community Safety Team has introduced a 'dial in' hub for partners to address any reported antisocial behaviour issues and they are now also facilitating a dial in for town and parish councils to enable any of their concerns to be addressed.

Partnership working with our town and parish councils is, more than ever, key to our work within our communities going forward alongside our volunteers.

Support for businesses

- Uttlesford Discretionary Grant Fund The scheme closed on 21 June and we are not accepting any new applications at this point in time. We have received more than 230 applications. Those that are assessed as meeting the eligibility criteria will be prioritised for grants. We would remind applicants not to chase their application our officers are working as quickly as they can and will notify all applicants of a decision as soon as possible.
- Business support grants We have paid out more than £18 million in government support grants to around 1,500 local businesses. If there is a village hall or community centre in your parish that is run by a trust or something similar and is in receipt of Small Business Rate Relief, it may be eligible for the Small Business Grant (<u>www.gov.uk/guidance/check-if-youre-eligible-for-the-coronavirus-small-business-grant-fund</u>) or the Retail, Leisure and Hospitality Grant (<u>www.gov.uk/guidance/check-if-youre-eligible-for-the-coronavirus-retail-hospitality-and-leisure-grant-fund</u>). Lots of village halls have already received grant funding.
