#### 426. Correspondence

### 430. Potholes on lane to school

# 431. Bluebell Wood bridleway

SK has spoken to the Environmental Agency regarding a possible leak from a septic tank adjacent to the bridleway. This is being investigated.

## 432. Football Field

TC advised that ground preparation is proceeding. The posts will be installed shortly, following refurbishment. An inspector is due to visit in June.

A donation has been received which will cover the cost of the concrete foundation.

## 433. UDC Highways Devolution Pilot

District Councillor Anthony Gerard advised the council not to take any action at this time as there may be changes to the project following a new County administration.

### 434. Planning

# a. UTT/19/0700/FUL - Birds End, Brixton Lane

Demolition of outbuilding and erection of 1 detached dwelling.

The Parish Council does not object to the style of the planned building which is in keeping with the traditional style of the village. Should a building be built on this plot the PC approves of the plan for the building to be set into the landscape so as to achieve a low profile. The PC is pleased that the entrance to the extant property be used to serve the proposed building and that there is no requirement for an additional entrance onto Brixton Lane. However, the PC does note, and is concerned, that Brixton Lane is an unspoilt single lane road with few passing places and that this proposal will result in an increase to the vehicles using the lane.

# b. UTT/19/0644/HHF – The Gables, Rickling Green Road

Creation of driveway to the front of the property to provide parking for two vehicles.

### 435. Waterbutt Row parking

An email has been received from Rissa Long, details as follows;

"Last year the Uttlesford LHP had recommended funding towards a feasibility study outside Waterbutt Cottages on Cambridge Road in Quendon as below to help regulate the manner in which parking happens. When my engineering colleague had attended site a short while back he had spoken to several of the residents who live along this stretch who indicated that they did not envisage that there was a problem and that they would not support the progression of any measures.

The concept of what we would have been exploring would have been for unofficial marks to be introduced to the footway to delineate how far in cars should be parking but due to the markings being unofficial and thus unenforceable they would have relied on the residents to work with the Parish and ECC in order for this to be a success.

As the residents have indicated that they are not in support then there would be little benefit to proceeding any further with this project."

PW will respond to Rissa Long. It is hoped that a feasibility study will be instigated to study the parking problem.

## 436. County and District Councillor reports

Anthony Gerard confirmed that he and Neil Hargreaves had been re-elected as district councillors. The composition of Uttlesford District Council is now:
