## 1634. Football Pitch

The Parish Council has handed over the full running of the football pitch to Ted Crow (TC), together with any equipment which the PC owns. TC is now running the project independently. He has been offered a £1000 grant from Cllr Neil Hargreaves (NH). The money has to be paid into a commercial account, which TC does not currently have, and before 15<sup>th</sup> March 2025. NH wonders if the money can be paid into the PC 's bank account and then transferred to TC when he has set up a commercial bank account. The parish clerk was not sure if this would be acceptable and is seeking advice from EALC. If EALC advise that this would be acceptable it must be made clear to TC that the transfer must take place before 31<sup>st</sup> March 2025. The clerk will report back when the advice is received.

It is clear from the accounts that expenditure relating to the football pitch substantially exceeds income received from football pitch hire.

# 1639. County and District Councillor reports

## **Neil Hargreaves**

NH has sent a report.

- For 2025/26 there is an intended rise in council tax of £5.28 per year which takes the Band D rate to £182.02.
- The Blueprint project has generated £2.5 million of continuing savings.
- A five-way split is being sought for Essex. Uttlesford is likely to combine with Harlow and Epping Forest.
- I intend giving £1000 from my ward initiative to the Football Pitch operation. This must go into a commercial account, which has not yet been set up, and must be paid by middle of March when the funding is no longer available.

# **Judy Emanual**

- The government has published it's various methods of streamlining councils. This will include a mayor for Essex.
- All new funding will then go through the mayor. Below the mayor will be unitary and district councils. It is expected that there will be 5 unitary authorities in Essex.
- There is a proposed 90 home development Newport.
- There is speculation that a travellers site might be established in Chalk Farm Lane, Newport.
