475. Mobile Phone coverage

There are still parts of the village which are not covered. The parish clerk is to write to the local MP Kemi Bedenoch to ask her to take some action to remedy the situation.

476. Various upkeep issues

- a. Removal of dead tree KN has reported this. SK has been advised that some other trees are showing signs of distress. The situation is to be monitored.
- b. Quotation for clearing the village pond No action to be taken for the time being.
- c. Strimming Strimming by the school has been carried out by a parent.
- d. Rat hole This is active. Brian Blackwell has put down bait.
- e. Verge at Bluebell Drive TD advised that a resident has volunteered to cut the verge.

477. Quickling Festival

This is scheduled for Saturday 10th August. There has been local advertising for the event and Mullocks will be putting up a number of signs. Many prizes have been donated.

478. Potholes on School lane

Repairs to the potholes have been completed. The school has requested a grant/donation from the parish council towards the cost of the works. It was commented that the work is likely to benefit mainly parents driving their children to school, or patrons of the Cricketers Arms and that these are more likely to be non-residents of the village. The parish council does have a grants policy which requires that any grant should benefit a reasonable number of residents. In view of the apparent benefit to only a small number of residents, the council feels minded to decline the request.

The parish clerk will write to the school explaining the parish council's decision.

479. Runfest 2019

A donation has been received from the organisers in thanks for use of the football pitch surrounding environs for parking. The event went very well although it was noted that there was some parking on the actual football pitch, which was against instructions.
