c. PCC Grant

BC proposed that the PCC should be asked to provide an update on construction of the toilet facilities. If the construction work is still some way off, the grant money should be refunded. 382. Correspondence

SK has been advised that there is mud deposited on the bridle path at Bluebell Wood. The contractors have advised that this will all be cleared when their work has been completed.

There is a cycle race due to come through the village.

A request has been received for a memorial to be erected on the green to remember WW1 and WW2 veterans.

383. Potholes on road to school entrance

An estimate for the work has been received, which is £6081 just for patch repairs and £14602 for patch repairs and surface outlay. BC has emailed Ray Gooding to ask if, in view of the road being close to the school entrance, the Education Authority would finance the repair. He is still awaiting a reply. ES will put on Facebook.

384. Football Field

TC gave a general progress report. Some of the points are as follows.

- The pitch is to be inspected shortly to assess it's suitability.
- Strutt and Parker have advised that the buildings can be accessed.
- Cutting of the grass is now needed.
- The goal posts will be removed and renovated.
- The lease is still one year less (at 20 years) than the 21 years required by the Football Foundation to qualify for funding.

385. UDC Highways Devolution Pilot

The parish clerk will be attending a briefing on the project on 25th March and will provide a full report for the council's consideration. **[KW]**

386. Cambridge Road B1382

a. Speed limit on B1382

NH advised that nothing has yet been decided although there is a possibility of 40 mph buffer zone. Ray Gooding (County Councillor) has not yet advised if the speed limit signs are to be moved.

b. Speeding

The Speedwatch team continues to monitor speeding cars through the village.

c. Parking at Waterbutt Row

It has been suggested that an independent consultant be employed to offer a solution. NH advised that the Neighbourhood Plan group does have a consultant who is looking at various issues, one of which is parking at Waterbutt Row. Any conclusions can then be referred to Highways for action.

387. Neighbourhood Plan

The Heritage section of the steering group recommends that heritage properties, with the owners' permission, be fully described in the Plan which will aid protection. There will in due course be a referendum on the Plan, although the date has not yet been agreed.

388. Special Constables (report circulated)

The question of a local volunteer will in the first instance be posted to Facebook and mentioned in The Link. If there is interest shown then the parish council would like to make further enquiries

389. Risk Assessment (report circulated)

With removal of reference to "play equipment" the Risk Assessment document was adopted.

390. Lighting

The parish council has been trying to arrange for UK Power Network to trim the trees overhanging the light on power pylon alongside Yew Tree Cottage but with so far no success. The parish clerk has therefore been instructed by Quendon and Rickling Parish Council to advise UK Power Network that if the work has not been carried out by the end of March the parish council will employ it's own contractor and then present the bill to them for reimbursement.

Proposed barn conversion to 1 dwelling including extensions and alterations.

b. UTT/19/0362/FUL – Barn at Hill House

Proposed barn conversion to 1 dwelling including extensions and alterations with proposed new vehicular access.

The proposal is a relatively small building which may comply with the future housing wishes of the Parish.

The proposal would significantly overlook adjacent and opposite properties. A new access to the Cambridge road is unacceptable, especially as it would mean demolishing part of an established wall.

The existing building has a character and historic value.

d. UTT/19/0006/FUL – 2 Rickling House Cottages

Construction of 2 dwellings and associated garage block within the rear garden. The Parish Council objects to the proposal for the following reasons:

The proposal sits within the conservation area and outside the development (i) boundary, which the Parish Council thinks should be respected.

The proposed houses are large and do not meet the wishes expressed by the (ii) village, (in the form of the Village Plan), for smaller houses within the village.

The proposed houses will remove an open space within the village and (iii) contribute to greater housing density.
